Q-What Does Your Training Include?

A:A combination of classroom and hands-on training in a series of truck and workplace related topics. Classroom training lasts about 2 hours and the hands-on portion approximately 3 hours. IMSC offers a comprehensive safety training program that addresses key training issues, including pre-operational inspection, operating safety guidelines, safe load-handling techniques and fueling gasoline and diesel machines.


